NCC requirements for insulation in commercial building fire rated walls

The National Construction Code (NCC) 2019 requires all components of external walls, common walls, and internal non-load bearing fire rated walls, for Type A and Type B buildings to be non-combustible. This means that components of the wall including insulation must be non-combustible.

Fletcher Insulation provide an extensive range of non-combustible solutions for compliance in external and internal walls, offering enhanced fire, acoustic and thermal performance. For bulk insulation, these products include Pink® Partition, Pink® Batts and Pink® Soundbreak® wall batts, depending on the building design and requirements. Non-combustibility is achieved by either fulfilling the non-combustibility criteria of AS 1530.1 or exempted by Clause C1.9 (d) and (e) of the NCC.

Outside of the structural or divisional function of a wall system, fire, thermal and acoustic properties are the fundamental components to be considered as part of a wall system's design and performance. While external or internal walls require non-combustible insulation, it is a common prerequisite for insulation to also provide undisturbed acoustic conditions and optimal thermal performance for the well-being of occupants.

Pink® Partition, Pink® Batts and Pink® Soundbreak® are non-combustible, glasswool insulation products designed to provide a reduction in acoustic transmission in walls. Maintaining their fit and firmness in the wall cavity ensures the insulation remains in place for ongoing thermal performance and safeguards the prevention of potential gaps in the walls caused by slumping of other types of insulation.

Pink® Partition is available in a range of densities, enabling the acoustic and thermal performance to be modified to suit any project requirements. This range of densities available go up as high as 32kg/m³ and thicknesses up to 165mm, providing up to R3.5 added insulation to the total wall thermal performance.
